THIS AGREEMENT, made this _____ day of September ~~2022~~ **SEP 21 2022** between **SANTA MARIA WATER DISTRICT** and **OMNICHRON SECURITY AGENCY, INC.**

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

OMNICHRON SECURITY, INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at A & S Building, J.P. Rizal Street, Poblacion, Santa Maria, Bulacan, represented by its President, **JAMIESON O. GO** hereinafter called the **SECURITY AGENCY**.

WITNESSETH:

WHEREAS, in response to the ENTITY's Invitation to Bid, the **SECURITY AGENCY** submitted its bid to the Procuring Entity to provide **SUPPLY OF SECURITY SERVICES IN VARIOUS SMWD OFFICES FOR THE MONTH OF SEPTEMBER TO DECEMBER 2022**;

WHEREAS, the bid of the **SECURITY AGENCY** was the **Single Calculated and Responsive Bid**;

WHEREAS, the ENTITY has awarded the Contract to the **SECURITY AGENCY** at the price stipulated in its winning BID of **ONE MILLION TWO HUNDRED THIRTY SEVEN THOUSAND SEVENTY FIVE PESOS AND NINETY TWO CENTAVOS (Php1,237,075.92)** inclusive of government taxes;

WHEREAS, the Entity is desirous that the Contractor execute the project, "**SUPPLY OF SECURITY SERVICES IN VARIOUS SMWD OFFICES FOR THE MONTH OF SEPTEMBER TO DECEMBER 2022**" (hereinafter called "the Services") and the Entity has accepted the Bid for **ONE MILLION TWO HUNDRED THIRTY SEVEN THOUSAND SEVENTY FIVE PESOS AND NINETY TWO CENTAVOS (Php1,237,075.92)** by the **SECURITY AGENCY** for the supply of services in accordance with the Terms of Reference

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - (a) the Bid Form and the Cost Distribution Wage of the guards;

- (b) the Terms of Reference;
 - (c) the General Conditions of Contract;
 - (d) the Special Conditions of Contract;
 - (e) Supplemental/Bid Bulletin, if any;
 - (f) the Eligibility, Technical and Financial Documents
 - (g) the Entity's Notification of Award and the bidder's conforme thereto;
 - (h) the Performance Security; and
 - (i) Other contract documents that maybe required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
3. In consideration of the payments to be made by the Entity to the Security Agency as hereinafter mentioned, the Security Agency hereby covenants with the Entity to provide the services and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Contractor in consideration of the provision of the services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
5. The contract amount of One Million Two Hundred Thirty Seven Thousand Seventy Five Pesos and Ninety Two Centavos (P 1,237,075.92) is applicable for the months, September to December 2022. The duration of services is for THREE (3) years, from September 2022 to August 2025 and the SMWD shall allocate budget for the particular succeeding Fiscal Years (FY). The contract may likewise be extended by the SMWD for a maximum of six (6) months, subject to the result of the performance evaluation of the Contractor, exigency of service, availability of funds and upon mutual agreement of the parties.
6. This contract maybe amended or terminated prior to contract expiration with justifiable reasons. A written notification shall be done thirty (30) days prior to termination of contract.
7. For other stipulations and conditions, the parties concerned may refer to the Terms of Reference (TOR).
