

CONTRACT AGREEMENT CA-2022-12-033

PROJECT: SUPPLY AND DELIVERY OF ADDITIONAL CLASS "B" WATER METERS REQUIREMENT OF THE SMWD FOR CY 2022 Reference No. PB2022-SMWD-G-10-016

THIS AGREEMENT, made this 27th day of December 2022 between SANTA MARIA WATER DISTRICT and ALUMINATES METERING SUPPLY CO., INC.

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 3 M. de Leon St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS**, **JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

ALUMINATES METERING SUPPLY CO., INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at No. 20C Malaya Street, Malanday, Marikina City represented by its General Manager, **GLORIA B. BERTUMEN**, hereinafter called the **SUPPLIER**.

WITNESSETH:

WHEREAS, in response to the ENTITY's Invitation to Bid, the SUPPLIER submitted its bid to the Procuring Entity to deliver SUPPLY AND DELIVERY OF ADDITIONAL CLASS "B" WATER METERS REQUIREMENT OF THE SMWD FOR CY 2022:

WHEREAS, the bid of the SUPPLIER was the Single Calculated and Responsive Bid;

WHEREAS, the **ENTITY** has awarded the Contract to the **SUPPLIER** at the price stipulated in its winning BID of **ONE MILLION TWENTY THOUSAND PESOS (PhP1,020,000.00)** inclusive of taxes;

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF ADDITIONAL CLASS "B" WATER METERS REQUIREMENT OF THE SMWD FOR CY 2022 (hereinafter called "the Goods") and the Entity has accepted the Bid for ONE MILLION TWENTY THOUSAND PESOS (PhP1,020,000.00) by the Supplier for the supply and delivery of such Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.





- 2. The following documents as required by the 2016 revised Implementing Rulea and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this agreement, viz:
 - (a) Schedule of Requirement;
 - (b) Technical Specifications.
 - (c) Bid Data Sheet
 - (d) General and Special Conditions of Contract
 - (e) Supplemental/Bid Bulletin
 - (f) Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents/statements submitted;
 - (g) the Entity's Notification of Award;
 - (h) the Performance Security; and
 - (i) Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract
- 3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the water meters identified in the bidding documents and to remedy defects therein in conformity in all respects with the provisions of the Contract.
- 4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
