Project: SUPPLY AND DELIVERY OF BRASS AND G.I FITTINGS REQUIREMENT OF THE SMWD FOR CY 2023

THIS AGREEMENT, made this 26th day of April 2023 between **SANTA MARIA WATER DISTRICT** and **JEMA FUTURE-BEST ENTERPRISE**.

KNOWN ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 302 J.P Rizal St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

JEMA FUTURE-BEST ENTERPRISE, a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at No. 15 Via Pisa St., Villa Firenze Subd., Tandang Sora, Quezon City, represented by its Owner/Sole Proprietor, **MATINA M. MALACAS** hereinafter called the **SUPPLIER**.

WITNESSETH:

WHEREAS, in response to the ENTITY's Invitation to Bid, the **SUPPLIER** submitted its bid to the Procuring Entity to deliver **SUPPLY AND DELIVERY OF BRASS AND G.I FITTINGS REQUIREMENTS OF THE SMWD FOR CY 2023** for **SANTA MARIA WATER DISTRICT**;

WHEREAS, the bid of the **SUPPLIER** is the **Single Calculated and Responsive Bid**;

WHEREAS, the ENTITY has awarded the Contract to the **SUPPLIER** at the price stipulated in its winning BID of **TEN MILLION FOUR HUNDRED FORTY THOUSAND SIX HUNDRED SEVEN PESOS (Php10,440,607.00)** inclusive of taxes.

WHEREAS, the Entity is desirous that the Supplier execute the project, "**SUPPLY AND DELIVERY OF BRASS AND G.I FITTINGS REQUIREMENT OF THE SMWD FOR CY 2023**" (hereinafter called "the Goods") and the Entity has accepted the Bid for **TEN MILLION FOUR HUNDRED FORTY THOUSAND SIX HUNDRED SEVEN PESOS (10,440.607.00)** by the Supplier for the supply and delivery of such Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, viz:
 - i. Philippine Bidding Documents (PBDs);

- i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**

3. In consideration of the payments to be made by the Entity to the Supplier as hereinafter mentioned, the Supplier hereby covenants with the Entity to provide the brass and galvanized iron (GI) fittings identified in the bidding documents and to remedy defects therein in conformity in all respects with the provisions of the Contract.
4. The Entity hereby covenants to pay the Supplier in consideration of the provision of the goods and services and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the time and in the manner prescribed by this Contract.
5. This Contract Agreement shall take effect from the receipt of the Notice to Proceed (NTP) until the Issuance of Certificate of Completion by the Procuring Entity.

IN WITNESS whereof the parties thereto have caused this Agreement to be executed the day and year first before written.
