

CONTRACT AGREEMENT CA-2023-10-017

PROJECT: SUPPLY AND DELIVERY OF CLASS "B" WATER METERS FOR ADDITIONAL REQUIREMENTS OF THE SMWD FOR CY 2023 Reference No. SMWD-PB2023-G-09-011

THIS AGREEMENT, made this __v^t day of November 2023 between **SANTA MARIA WATER DISTRICT** and **ALUMINATES METERING SUPPLY CO., INC.**

KNOW ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 302 J.P. Rizal St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And-

ALUMINATES METERING SUPPLY CO., INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at No. 20C Malaya Street, Malanday, Marikina City represented by its General Manager, **GLORIA B. BERTUMEN**, hereinafter called the **SUPPLIER**.

WITNESSETH:

WHEREAS, in response to the ENTITY's Invitation to Bid, the SUPPLIER submitted its bid to the Procuring Entity to deliver SUPPLY AND DELIVERY OF CLASS "B" WATER METERS FOR ADDITIONAL REQUIREMENTS OF THE SMWD FOR CY 2023;

WHEREAS, the bid of the SUPPLIER is the Single Calculated and Responsive Bid;

WHEREAS, the Entity is desirous that the Supplier execute the project, "SUPPLY AND DELIVERY OF CLASS "B" WATER METERS FOR ADDITIONAL REQUIREMENTS OF THE SMWD FOR CY 2023 (hereinafter called "the Goods") and the Entity has accepted the Bid for FIVE MILLION NINE HUNDRED TWENTY THOUSAND PESOS (PhP5,920,000.00) inclusive of taxes by the Supplier for the supply and delivery of such Goods and the remedying of any defects therein.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

- 1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
- 2. The following documents shall be attached, deemed to form, and be read and construed as integral part of this agreement, viz:





- i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
- ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;

- iii. Performance Security;
- iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
- v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.
- 2. In consideration for the sum of Five Million Nine Hundred Twenty Thousand Pesos (Php5,920,000.00) or such other sums as may be ascertained, ALUMINATES METERING SUPPLY CO., INC. agrees to provide the water meters in accordance with his/her/its Bid.
- 3. The SANTA MARIA WATER DISTRICT agrees to pay the above-mentioned sum in accordance with the terms of the bidding
- 4. This Contract Agreement shall take effect upon signing and sealed by both parties until the Issuance of Certificate of Completion by the Procuring Entity.
