**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROJECT:

WHEREAS, the Santa Maria Water District BAC secretariat has published In PhilGEPS and SMWD’s website an invitation to Bid for the above stated project for the period September 27 to October 3, 2023. The same invitation was sent to three (3) observers and was also posted in the Digital Bulletin Board of the of the Santa Maria Water District’s office on the same period;

WHEREAS, on October 9, 2023, Supplemental/Bid Bulletin No. 2023-006 was issued and posted in Philgeps and SMWD website to inform the prospective bidders of clarifications made in the bidding documents as a result of what has been discussed and agreed upon during Pre-bid Conference held on October 5, 2023. Copy of Supplemental/Bid Bulletin was also sent to prospective bidders through electronic mail (email) for their reference;

WHEREAS, in response to the said invitation, only one (1) prospective bidder purchased and submitted bidding documents prior to Bid Opening on October 17, 2023 at 1:00PM. The bidding documents were submitted by Ms. Odessa Mae Pepito and Mr. Ryan Astrero of Aluminates Metering Supply Co., Inc. on the same day at 11:20 AM. Cut away samples of the water meter were also submitted together with the bidding documents;

WHEREAS, on the same day, October 17, 2023 at 1:00 PM, the eligibility documents of the bidder, were opened and passed the preliminary examination of bids. The documents were thoroughly checked and verified. The Eligibility and Technical Documents were found complete and in order, thus, the BAC declared **Aluminates Metering Supply Co., Inc.** eligible to bid, and the BAC proceeded in opening the Financial Envelope. The financial offer was read out, to wit:
