**BAC RESOLUTION RECOMMENDING AWARD FOR THE PROJECT:
SUPPLY, DELIVERY, AND TESTING OF AIR COMPRESSOR FOR THE SANTA MARIA WATER DISTRICT

WHEREAS, the Santa Maria Water District BAC secretariat published In PhilGeps and SMWD’s website an invitation to Bid for the above stated project for the period March 19 to 25, 2024. The same invitation was sent to three (3) observers such as Commission on Audit (COA), Soroptomist International of Santa Maria, and Bulacan Chamber of Commerce and Industry. The invitation was also posted in conspicuous premise of the Santa Maria Water District’s office on the same period;

WHEREAS, in response to the said invitation, only one supplier/dealer of Air Compressor purchased bidding documents and submitted the same on April 8, 2024 at 9:52 AM, prior to bid opening at 1:00 PM of the same day. Engr. Reynan Rhoel E. Dela Rosa, Product Engineer of Compresstech Resources, Inc. submitted the bidding documents properly sealed in one (1) red envelope;

WHEREAS, the BAC started opening the bidding documents of the sole bidder, Compresstech Resources, Inc., at exactly 1:00 P.M April 8, 2024. The BAC checked and examined the technical envelope which contain the eligibility, technical and financial documents. All the required documents were all present and in order. A duly notarized Bid Securing Declaration was the form of bid security posted which is an acceptable form as stated in the bidding documents. After concluding the eligibility of the bidder, the BAC commenced in the opening of the financial documents where it has passed the preliminary examination of bids, The financial bid did not exceed the approved budget for the contract, and the bid was read out, to wit:

WHEREAS, post-qualification was conducted on April 17, 2024 and careful examination, validation and verification of all the original eligibility, technical and financial components submitted by the sole bidder was done by the BAC. The members of the BAC, the BAC secretariat and the end-user have visited the office of the bidder and there, the offered air compressor, model PDS185S-6C2 with serial no. B4-6C2B555 was presented and tested. After thorough examination and testing of the unit, the BAC concluded that the bidder has complied with the technical specifications and thereafter, the bidder, Compresstech Resources, Inc., was certified as legally, technically and financially capable to implement the project, Supply, Delivery and Testing of Air Compressor for the Santa Maria Water District;

THIS AGREEMENT, made this 10th day of May, 2024 between **SANTA MARIA WATER DISTRICT** and **COMPRESSTECH RESOURCES INC.**

KNOW ALL MEN BY THESE PRESENTS:

SANTA MARIA WATER DISTRICT, a Government Owned and Controlled Corporation (GOCC) duly organized and existing under and by virtue of Presidential Decree No. 198, as amended, with principal office address at No. 302 J.P. Rizal St., Poblacion, Santa Maria, Bulacan, represented by its General Manager, **ENGR. CARLOS N. SANTOS, JR.**, duly authorized for this purpose, hereinafter called the **ENTITY**.

And -

COMPRESSTECH RESOURCES INC., a duly organized and existing entity under and by virtue of the laws of the Republic of the Philippines, with principal office address at CRI Building, 665 E. Quirino Avenue, Malate Manila, represented by its Product and Senior Sales Engineer, **ENGR. REYNAN RHOEL DELA ROSA**, hereinafter called the **SUPPLIER**.

WITNESSETH:

WHEREAS, in response to the **ENTITY's** Invitation to Bid, the **SUPPLIER** submitted its bid to the Procuring Entity to implement the project, **SUPPLY, DELIVERY, AND TESTING OF AIR COMPRESSOR FOR SANTA MARIA WATER DISTRICT**;

WHEREAS, the bid of the **SUPPLIER** is the **Single Calculated and Responsive Bid**;

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.

 - iii. General and Special Conditions of Contract; and

- iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conforme thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **Winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
